Membership

Transfers

National Bylaw Sec. 107 - Transfers.

A member may transfer from one Post to another Post as prescribed in Section 107 of the Manual of Procedure.

In the event that a transfer to another Post or Member-at-Large has been effected and it is subsequently determined that the conditions of the Member Declaration have not been satisfied, then the Department Commander, with respect to transfers within the Department, revoke, suspend or cancel such transfer.

Manual of Procedure Sec. 107 - Transfers.

A member may transfer from one Post to another Post provided the following conditions are met:

- 1) Completion of the application as prescribed in Section 102 of the Manual of Procedure.
- 2) Signing the Member Declaration as stated below.
- 3) Acceptance by the Post.

With respect to transfers from a Post to Department Member-at-Large, it is the National Organization's and/or the Department Headquarters' responsibility to ensure the above mentioned conditions have been met.

Member Declaration

“I hereby certify that it is my desire to transfer my membership. I further certify that I am not indebted to my former Post, be it through oral or written commitment or otherwise, and that, to the best of my knowledge, no written charges have been preferred against me by my former Post and I understand that any such indebtedness or charge which may be disclosed any time hereafter will render this transfer null and void.”

Members transferring should surrender their membership card to the Quartermaster of the accepting Post.

Looking to share updated information and materials on VFW's Voice of Democracy, Patriot's Pen and Teacher Award programs?

BUDDY POPPY POLICY AND PROCEDURES:

- 1) Departments must order poppies through OMS.
- 2) All claims of non-receipt of a Buddy Poppy order must be made within 60 days of the date of the order or will NOT be replaced free of charge.
- 3) All orders for the traditional Buddy Poppy, Anniversary Poppies or tin tab poppies must be placed through your Department Headquarters. Auxiliaries must go through their Post to order all poppies. Orders must specify, Post number, quantity and type of poppy – traditional, anniversary (25, 50 or 75) or tin tab poppies.
- 4) The tin tabs do count towards the Buddy Poppy requirement for the All-American program.
- 5) If you do not receive your order within four weeks of placing it with your department, please contact your Department Headquarters to report you have not received your order.
- 6) All poppies are shipped within 10 days of ordering except orders placed in June and July, due to preparation for National Convention, please allow an additional five business days.

Post Inspections:

As we near the completion of our Post Inspection cycle, Posts are reminded to wrap up and report to Department the completion of all items noted in their inspection report.

Post Bond & Trustee Report Deadline:

- **Bonding Requirement:** All individuals authorized to sign Post checks or responsible for Post property must be bonded. Bonds are valid from October 1, 2025, through September 31, 2026. Please submit one bond form per position/person along with a check by September 15, 2025.
- **Bonding Details:** Each Officer accountable for funds or property must be bonded with an approved amount and surety as required by the Department.
- **Trustee Reports:** Post Commanders must submit Trustee Reports of Audit to the Department Quartermaster for the following periods:
 - 4th Quarter: Ending June 30, 2025
 - 1st Quarter: Ending September 30, 2025
 - 2nd Quarter: Ending December 31, 2025
 - 3rd Quarter: Ending March 31, 2026

All Trustee Reports of Audit are due 30 days after the end of each Quarter. Trustees must sign the Audit. Posts must also submit banks statements, QM Record of Receipts and Disbursements or other supporting documentation with the Audit Report.

Post Elections:

Post Election Reports must be submitted following Post election of officers in April and no later than June 1 to the National Headquarters. We highly encourage all Post Quartermasters to use the online Election Report process featured in the Online Membership System (OMS). Post Election Reports received electronically will be forwarded to the Department Headquarters.

Delegate Fees: All Post Delegate Fees must be paid before the start of the State Convention. Forms are available on the Department Website using the following address
