# THE PURPLE HEART AWARD IS NOW A VFW QUALIFIER

VETERANS OF FOREIGN WARS COMMANDER-IN-CHIEF AL LIPPHARDT

At VFW's 125th National Convention, delegates approved M-2, an amendment to VFW's Manual of Procedure. The approval makes the Purple Heart a qualifying award for VFW membership.

The Purple Heart now stands alongside awards such as the Combat Infantryman's Badge, the Combat Medical Badge and the Combat Action Badge denoting that an individual has earned eligibility into our great organization. The Purple Heart is awarded for wounds received as a result of enemy action.

Most Purple Heart recipients would already be eligible for VFW membership through receipt of a campaign medal, but there are incidents that have occurred within the United States where the Purple Heart was issued by itself. U.S. troops wounded or killed in the Sept. 11, 2001, terrorist attacks, the 2009 shooting at the former Fort Hood in Texas and the 2015 terrorist attack on two military installations in Chattanooga, Tenn., are examples.

But let me be clear: The Purple Heart is a military award. It is not a civilian award, and civilian awards are not VFW qualifiers.

At VFW's recent convention, we had the honor of being joined by Robert Olivarez and Carder Ferguson, both VFW life members and life members of the Military Order of the Purple Heart. Robert is the current MOPH national commander and Carder is the MOPH immediate past national commander.

Carder has told the VFW that approximately 230,000 Purple Heart recipients do not belong to either the VFW or the MOPH.

These are potential VFW members that should be a part of our great organization.

I am proud of our new relationship with the MOPH. While the MOPH is and will remain a separate organization, the act of partnering with them in the cause of serving veterans will keep the MOPH's great legacy alive and bolster our own influence.

The VFW also has begun training and accrediting service officers who are VFW life members and MOPH life members. The first two participated in VFW's annual service officer training classes in September. The MOPH has chapters in areas of the country where the VFW does not have Posts, and vice versa. To me, it makes sense to be able to offer services to veterans at more locations around the nation.

Purple Heart recipients like me have shed blood for this country. I personally hold the medal in high esteem because it was created by Gen. George Washington, and the medal's history is that of the U.S. military.

The Purple Heart is one of the military's most esteemed awards, and anyone who earns it — anywhere in the world — can join our great organization.

#### Looking Ahead



They stay informed on challenges facing veterans, the military, and their families, and are ready to take action by contacting lawmakers. Open to all patriotic Americans, the Action Corps is free to join and helps amplify the voices of veterans' advocates across the country.

#### MEMBERS RECEIVE:

- -The VFW Action Corps Weekly newsletter, covering advocacy efforts.
  - -Access to contact information for elected officials nationwide.
- -Regular "Action Alerts" to engage when veterans' issues require attention.

The VFW Action Corps strengthens the VFW's mission to support veterans, working closely with the National Legislative Service in Washington, D.C., to drive change.

#### RECENT LEGISLATIVE VICTORIES INCLUDE:

- -The PACT Act, expanding VA healthcare for veterans exposed to toxic substances.
  - -The SERVICE Act, improving VA mammogram eligibility.
- -Reforms to the Uniform Code of Military Justice on sexual assault and harassment.
  - -VA's maternity care coordination program for women veterans.
- -The PAWS for Veterans Therapy Act, providing service dogs for veterans with PTSD.
- -Inclusion of bladder cancer, hypothyroidism, and parkinsonism as presumptive conditions for herbicide exposure.
  - -The Deborah Sampson Act, addressing healthcare barriers for women veterans.
  - -Removal of the 12-year limit on using Veteran Readiness and Employment (VR&E) benefits.
