VETERANS OF FOREIGN WARS COMMANDER-IN-CHIEF AL LIPPHARDT

The following is an excerpt of VFW Commander-in-Chief Al Lipphardt's acceptance speech at VFW's 125th National Convention in Louisville, Ky.

It is my custom when I speak to groups like yourselves, that I want five Vietnam veterans to join me: Pvt. Lewis Sloan, Cpl. Kenneth Adams, Cpl. Philip Adams, Pfc. Robert Waddell and Cpl. Rodney Loatman. But they can't.

Their names are inscribed on the Wall in Washington, D.C., but forever living in my heart. These men served under my command when they paid the ultimate price for freedom.

I promised myself that I would honor their service and sacrifice by saying their names whenever I had the opportunity. No greater love hath a man than to lay down his life for another.

You elected me to lead this organization in accordance with VFW's National Bylaws, Manual of Procedure and Ritual. Lead I shall.

This year, our focus at all levels is on courage. Your courage is undeniable.

Many of our soldiers, Marines, sailors and airmen perceive they are but pawns to be used over and over in this Global War on Terror. Even more dangerous to this nation is the failure of its leaders to keep the promises they made to those ordered to place their bodies between the weapons of our enemies and these shores. Slowness to grant health care and service-connected disabilities is only one part of this failure.

Credibility also is known as integrity. You can only claim one element that belongs to no one else, and that is your word. Of the values we learned — loyalty, duty, respect, selfless service, integrity, honor and personal courage — none is more important than integrity.

If your word is not to be trusted, everything and anything you do is unreliable. You can't be called on nor can you be counted on. There is no place in the Veterans of Foreign Wars for these individuals.

When you talk about members of the VFW, you are talking about our nation's heroes and warriors, of men and women who would sacrifice all to keep our loved ones safe and secure in accordance with our Constitution, that all men are created equal and endowed by their creator with inalienable rights of life, liberty and pursuit of happiness.

Evil exists and it cannot be appeased, reasoned with or converted. Evil is, and there is only one way to eliminate it, and that is to destroy it wherever it appears. Like many of you in this room, I have seen the face of evil.

My ask is for you to embrace the vision of courage. Rekindle the warrior's fire in your belly. Put that vision into action. I am proud to lead you, as together, we seek the courage to be the best we can be in all things and at all times.

God bless you, the VFW, its Auxiliaries, and God bless the United States of America. Follow me.

VFW NATIONAL: VETERAN SERVICE OFFICERS

I HIGHLY RECOMMEND VFW SERVICE OFFICERS

After 26 years in the military, veteran Mary Maier, 73, lives in Ewa Beach, Hawaii. She joined the Army in 1973 when it began opening to women and served as a military police officer. Maier retired as a colonel after serving as a brigade commander at Fort Liberty (formerly Fort Bragg) in North Carolina.

"I found that I truly loved serving in the military and being a military police officer," Maier said.

While at Fort Liberty, Maier sustained repetitive injuries during her airborne assignments. She has undergone a knee replacement, knee surgeries and three back surgeries, one of which was to replace two discs in her neck. Maier also had cancer due to burn pit exposure in the first Gulf War.

"I've always enjoyed physical activity, but needed to cut back. I had seven major surgeries that required my family to help with my recovery. It's also reduced our ability to travel and do many of the things we planned for my retirement," Maier said.

VFW Accredited Service Officer Richard Barlett helped Maier with her VA claim by providing thorough explanations of the claims process and her service-connected injuries, He also provided advice on how to proceed with the claim, including how to gather evidence and what to expect from the exams.





Maier retired with a 40% rating. With Barlett's assistance, her rating increased to 90%, with one outstanding issue to resolve. "The paperwork for a VA claim is extensive and daunting if you have not worked with it before. Richard, along with others in his office, talked me through each of my conditions," she said.

For veterans in a similar situation, Maier believes that a good VFW accredited service officer can make all the difference when filing a claim. "The VFW's [accredited] service officers were absolutely knowledgeable and professional. I highly recommend them."

DOD IMPROVES INSTALLATION ACCESS FOR ELIGIBLE VETERANS AND CAREGIVERS

The Department of Defense (DOD) in partnership with the Department of Veterans Affairs (VA) announced today an improved installation access process for veterans and caregivers eligible for medical appointments, shopping at commissaries and exchanges, and taking advantage of certain morale, welfare, and recreation (MWR) services. Veteran and caregiver eligibility will now be electronically verified during the installation access process.

Eligible veterans who do not have a VA-issued Veteran Health Identification Card (VHIC), as well as eligible caregivers, can enroll for installation access at the visitor center using their REAL ID Act-compliant driver's license or non-driver's identification card. Starting November 1, 2024, Veterans without a VHIC, as well as eligible caregivers, no longer need to present a VA-issued caregiver patronage letter, VA-issued service-connected disability letter, or VA Health Eligibility Center Form H623A to enroll for installation access.

Eligible Veterans who do not have a VHIC, as well as eligible caregivers, will still need to provide a copy of their VA-issued caregiver patronage letter, VA-issued service-connected disability letter, or VA Health Eligibility Center Form H623A to show eligibility at the commissary, exchange, or authorized MWR services, since these facilities cannot electronically verify eligibility. Currently — for purposes of MWR, commissary, and exchange shopping — eligible caregivers are those who are approved and designated as a primary family caregiver of an eligible Veteran under VA's <u>Program of Comprehensive Assistance for Family Caregivers</u>.

"Our veterans and their caregivers deserve a smooth experience in accessing installations," said Ashish S. Vazirani, who is performing the duties of Under Secretary of Defense for Personnel and Readiness. "We are glad to work with the Department of Veterans Affairs on this initiative and look forward to continuing to welcome eligible veterans and VA caregivers to military exchanges and commissaries, and at eligible facilities like golf courses, movie theaters and clubs."

The VA-DoD partnership will make it easier for our nation's veterans and their caregivers to more easily access benefits and services on military installations, including VA medical appointments," said Tanya Bradsher, Deputy Secretary of Veterans Affairs.

To enroll for reoccurring installation access, individuals must visit each installation's visitor center. As with all individuals seeking installation access, eligible veterans and caregivers must establish identity, fitness, and purpose on their first visit to each DOD installation by stopping at the installation visitor center, where they will:

- (1) Present an acceptable credential (VHIC or REAL ID) to establish identity;
- (2) Undergo an on-the-spot criminal record and terrorism check to establish fitness; and
- (3) Have their eligibility for on-installation benefits verified electronically, to establish purpose. If your purpose is for health care, and the DOD installation doesn't have a commissary, exchange, or authorized MWR service, then proof of appointment will need to be provided.

Once a VHIC or REAL ID is enrolled for recurring access at an installation, at future visits the eligible patron can go directly to the installation gate and present the same VHIC or REAL ID enrolled at the visitor center to gain access. Enrollment is typically valid for one to three years, or one year after the last visit to the installation. If a patron's VHIC or REAL ID expires, they will need to reenroll with their new VHIC or REAL ID. The termination of eligibility under the Patronage Expansion Act will automatically result in the termination of installation access enrollment.
